Overview

As part of the Government's commitment to transforming and improving access to civil justice, The Department of Justice and Constitutional Development implemented Court-Annexed Mediation into courts across the country as of December 2014.

In preparation for these changes and to further the cause of mediation as an efficient and cost-effective alternative form of dispute resolution, the Association of Arbitrators (Southern Africa) NPC (AoA) sought to forge a relationship with an experienced, internationally accredited, mediation training provider in order to bring the very best in accredited mediation training to it's members and to Africa.
