The Johannesburg Global Pound Conference (GPC) event is part of an international series of events taking place in approximately 40 cities and 31 countries. The series will facilitate the development of 21st century commercial dispute resolution tools, at domestic, regional and international levels. It is a one-day programme that involves all participants using a unique <u>interactive technology platform</u> that includes multiple choice and open text questions to generate comparable and actionable global data. The goal is to consider improvements that can be made to all forms of dispute resolution, including litigation, arbitration, conciliation, mediation and mixed modes of preventing and resolving commercial disputes. The GPC Series will convene all stakeholders in dispute resolution -- commercial parties, lawyers, academics, judges, arbitrators, conciliators, mediators, ombuds, policy makers, and others -- at conferences around the world. 
