CONSTRUCTION GUARANTEES, PAYMENT GUARANTEES, AND SECTION 20 APPLICATIONS IN ARBITRATION

BACKGROUND:

A **Construction Guarantee** is similar to a letter of credit. Most construction contracts require the contractor to provide a construction guarantee to the owner (or employer) guaranteeing the contractor's performance undertaken in terms of the contract, or principal building agreement (PBA).

A **Payment Guarantee** is a financial commitment requiring the debtor to make a repayment based on the terms outlined in the original debt agreement, and which is sometimes backed with some kind of security such as property or another asset that is accepted by the lender.

A **Section 20¹ Application** is an application to refer a question of law arising in the course of an arbitration in the form of a special case for the opinion of the Court or for the opinion of Counsel. The opinion referred to shall be final and not subject to appeal and shall be binding on the parties to the arbitration.

Antony, who was born and bred in Bloemfontein, qualified as an attorney in 1992, having graduated at the University of Cape Town. He is a partner at <u>Maurice Phillips | Wisenberg</u> where he has practised since 2000.
