AD HOC ADJUDICATION IN THE CONTEXT OF THE 3RD EDITION OF THE GCC CONTRACT – A CASE STUDY

ABOUT THE WORKSHOP:

Adjudication is an accelerated form of dispute resolution. A neutral third party decides the dispute as an expert, not as an arbitrator. The adjudicator's determination is immediately enforceable as a contractual obligation.

Adjudication in the context of the 3rd Edition (2015) of the GCC Contract will be considered. There will be a case study, including the "Decision" of a Dispute Adjudication Board.

The case study will demonstrate how a number of issues can be dealt with: The defence of *lis pendens*, a time-bar defence, whether the contract was for a fixed term or whether it expired by effluxion of time, repudiation of the contract and the authority of the Employer's Agent to issue a Final Payment Certificate.
